(1) full footnote
(2) shortened footnote
(3) bibliography entry

CLASSICAL, MEDIEVAL, OR EARLY ENGLISH LITERARY WORKS (Turabian 17.8; CMoS 14.253; SBL 6.4.2)

[Since classical, medieval, or early English works are in the public domain and have been widely published over the centuries, these works can often be cited by book, canto, stanza and line; act, scene, and line; or similar divisions. This form works well for works written in the original language, such as the Augustine example.]

In the first example, the student is using a translation by Raymond Canning. In a doctoral dissertation, project or thesis, we recommend creating an abbreviation in the List of Abbreviations. For example:

The footnote includes the citation followed by the (translator's name, page number).

Electronic Book (Online)

[Documents that are no longer in copyright are often freely available online. However, these sources should not be cited as a website. Responsible writers make every attempt to use a source that provides scanned pages with the original title and copyright pages and fixed page numbers. When using the online version of a document, the URL should be the last part of a **full** citation based on the principles outlined in Turabian (9th ed.).]

[In a commentary series, each book has its own title and its own author. The series will also have a title. Include the series volume number if available. When citing a book in a commentary series, the book title is italicized, but the title of a commentary series is not italicized.]

Commentary Set (Turabian 17.1.8.2)

In the following example, commentaries on Matthew and Mark are bound together in one volume, but each commentary has a different author. *Matthew* is in italics because it is a book-length contribution to the volume. Therefore, the citation is similar to the "Chapter in an Edited Book" citation. Do not forget to add editor name(s) and the page range of the contribution in the bibliography entry.]
